# **Southern Water**

I received the full Electro Scan report on the sewers within the parish. This identifies stretches of sewer that urgently need repair/replacement. In particular, a 90m stretch where it crosses the Leys field, which, based on 1 foot head of water, the report says would leak nearly 157k litres per day (around 110 litres per minute).

The Electro Scan surveys estimate leaks from the pipeline; hence the estimated 1ft head of pressure. But when the ground floods and the water flows *into* the pipe, the pressure is higher, due to the water level above the pipe. The leakage rate is proportionate to the square root of the pressure; this means that, for example, 4 times the pressure results in twice the leakage rate (2 being the square root of 4). But the pipe is probably at least 6ft underground and the Leys field in winter is often flooded - so the leakage rate is likely to be around 400k litres/day or 280 litres/minute (four and half litres per second).

And that's just the worst 90m stretch - when you add in the rest of the leaks identified in the report, then using the same 6ft head of water, the total water ingress within the parish is over 1.6 million litres per day: over one metric tonne of water every minute.

I've yet to spell this out to Floyd Cooper - of course he has the report and he (or someone at SW) will be able to work it out for themselves. But I've told him enough to make it clear that we can read and interpret the Electro Scan report and, as will be seen from my latest correspondence with him, he's now promised to fix up a meeting - I'm awaiting his confirmation that this will be to make progress and not just a PR exercise.

# **Parish Design Statement**

Jane and I have discussed the descriptive narrative - the section that will precede the Design Guidelines - and we have agreed amendments. The next step is to circulate this to councillors to read and comment, with a view to gaining agreement of Council to endorse this section.

Apart from a short introduction still to write, that will then just leave the Appendices to be agreed - listing 'Cherished views', 'Cherished open spaces', plus anything else we feel deserves its own list.

# **Member of Maintenance Working Party**

Few more plants planted by the village pond wall. The new shrubs are establishing well as are the weeds which I am regularly removing. The bees love the catmint which is a joy to see as well as the newly hatched moorhen chicks.

# Village Hall

Fortunately, Viv was able to advise where the sand and sandbags were however I believe that the Charlton sand box could not be opened.

## **CHS Funding**

We had a great response from the questionnaires that we designed and circulated to residents in the community. 136 responses in total with an overwhelming acknowledgement that speeding issues exist within the village. We also had significant support for a 20mph limit around the school as well as over 50% support for the other traffic measures we set out as possible solutions. We have now designed a second questionnaire to go to non-residents and these will be circulated this week. We are currently analysing the resident's data and will then be doing a feedback session on 4<sup>th</sup> September to allow the community to see what measures we will be taking forward for funding. Once this is complete we will need to discuss our proposals with highways and all other stakeholders to fully work up and formalise the detail of each measure being supported and then we will be in a position to make the applications.

# **Gateways**

The gateway project has been delayed slightly because the Chichester volunteer person has gone off sick with a hand injury. We are looking at paying for the installation. The committee agreed at the meeting last week that we were in support of helping the weald and downland being accoladed on the signage where possible and we are working with the highways to come up with a solution that is suitable for all parties. The signage will be drawn up and distributed so we can vote on the final look in the coming days.

#### SID

Again, we are now looking at other installation options to ensure that the SID doesn't delay any longer due to the funding constraints with Igas. We will vote on the type of SID we would like to see in the villages at the meeting and this can then be ordered and installation arranged. The posts have been provided free of charge.

## **Funding**

We are now receiving funds from a number of areas which is fantastic news and progress for the projects we are wishing to move forward. Viv will create a spreadsheet of funding, so it is clear what is provided and for what project.

# Playground

The overview of the project has been circulated and needs to be voted on in the meeting. The quote needs to be finalised and also the funding approach. Once this is agreed funding can start. We have already drawn up an initial application for lottery fund but there will need to be several avenues sought for funding to cover the cost of the changes we wish to make.

Report regarding the Singleton & Charlton Emergency plan (including flood plan) The Emergency and Flood Action Plans - These are currently separate documents, which I feel should be combined, as a flood is an Emergency and therefore only one plan with one team or group responsible is needed. Many of the same people, both from within the Parish and outside emergency services and resources are the same. One easy to use document should detail the plan for the various emergencies types already identified and include quick and easy to locate contacts for the various aspects of any emergency I will undertake this work over the coming weeks, making it a priority due to the nature of it Emergency equipment - I have yet to complete the assets register, but suspect that some equipment listed in the current flood action plan and emergency plan is missing, or at least not located where it should be. The recent flooding highlighted the need for easy and fast access to equipment such as sandbags. Someone was unable to access the sandbags in Charlton, for the simple reason that the padlock was upside down and therefore very difficult to set the numbers correctly. I have now turned this the right way up I needed to access the emergency shed for hazard tape after flood, but was unable to as the code for the gate to access the sheds needs to be entered 'backwards', reading right to left, instead of the more obvious left to right. While these are minor details to address and publicise, if they prevent or delay access to emergency equipment, then we are rendered unable to assist, which could easily result in far more damage (in the case of a flood) than necessary. I will undertake to review access to and register of all emergency equipment, enabling the PC to publicise locations and access for all to use While keeping the majority of emergency equipment centrally (to Singleton at least) seems like a good idea, this leaves Charlton with nothing but some sand bags and a pair of 'road closed' signs kindly looked after by a Charlton resident. I would therefore like to investigate the possibility of distributing equipment more equally. I will do this and put suggestions forward to the PC once the asset register of emergency equipment is complete On a similar note, all the high visibility clothing is stored in the emergency shed. While there should be a stock in there, I feel that if each Councillor was given a set to keep at home, then they can easily wear this when leaving home to attend any emergency, rather than 9 people arriving at the shed at different times, unlocking and locking the gate and shed, then looking for their size etc. Perhaps the PC could also consider issuing at least a hi viz vest if not full kit, to those reliable

Parish residents who turn out to help on a regular basis. Let's keep our team safe while helping others! Proposals for PC to consider: 1 - Combine the Emergency plan and Flood Action plan into one comprehensive document 2 - Issue all Parish Councillors with High Visibility clothing 3 - Issue regular helpers with at least a High Visibility vest/ waistcoat

- Despite us having now 'officially' passed 'release day', we are still facing a number of challenges
  across the county, particularly around the economy. This will be especially critical as furlough

# Solar Together -

Spread the word that a county council-supported scheme to help residents install high quality solar panels and battery systems will re-open in the autumn. Through <u>Solar Together Sussex</u>, residents can get a high quality system installed to generate and store clean electricity and reduce their carbon emissions.

The scheme is run by Sussex councils in partnership with <u>iChoosr</u>, who use a 'group buying' approach to ensure that prices are competitive and systems are fitted by reputable, accredited installers. The previous Solar Together Sussex scheme, which opened in autumn 2020, is on course to install more than 500 solar PV systems by the end of this summer.

- Thirdly, I understand that the suspect drains in the middle of the village were attended to earlier this month. I hope that helped in the recent heavy rain, although I did note that the run-off from Goodwood land down North Lane looked pretty bad.

# **Henry Potter – District Councillor**

The District Councils Annual Report has just been published for the year 2020/21 and it shows that the clear priority has been to support our Residents, Businesses and Communities throughout the ongoing Corona 19 restrictions and the recovery stage which, needless to say, isn't over yet! Over the past 16 months CDC has distributed over £70 million of Central Government funding in small business support grants in three phases, the last of which closed on June 30th. Other grants were made to the public by way of a special Hardship Fund for those receiving Council Tax Reduction payments, and arrangements were hastily put in place to provide accommodation to get rough sleepers off the streets. At one stage there was only one rough sleeper who refused any help whatsoever. Although the offices at East Pallant House were closed to the public, the Customer Services team have managed successfully to deal with the thousands of enquiries either on-line or over the phone. These enquiries were magnified by the questions about safety during the crisis.it has been decided that CDC will continue to observe Covid 19 advice for the foreseeable future within the Offices at East Pallant house. This includes wearing face coverings when not seated and screened separation of attending Members at Meetings A motion has been proposed by a Member to reopen negotiations with Government Departments to address the transport issues around Chichester. This motion has been added to the Agenda for the Full Council Meeting on Tuesday 20th July. It includes a request that the consideration of the northern bypass be added to the list of options for solving the Transport problems which seem to be worsening almost daily and the day when the closure of the Oving Road Traffic lights is ever nearer.

The 5 yearly review of the Councils Taxi Licencing Policy and the Entertainment Licencing Policies have been presented to the Cabinet and will be approved and adopted by Full Council at the next meeting. The only major change in the Taxi Licencing Policy is to reduce, in a phased manner, the age of the vehicles used as taxis which will be limited to 10 years old.

A few words about the closure of the Centurion Way between Binderton bridge and the West Dean tunnel. This will remain closed off to the public until every Ash tree has been assessed for bat and dormouse habitation, and then safely felled. This will continue until late October when hibernation of these species takes place when the remaining Ash trees will be felled. Access will be restored from Binderton to the West Dean access (north of the School) but NO FURTHER until the bat survey is complete.

The extension northwards to the Southdowns Way is unlikely to progress for a good number of years due to certain lack of finance not helped by the impending purchase of the Seven Sisters Park from East Sussex County Council. This is requiring considerable investment in the Visitor Centre, car parking improvements and toilet facilities. This I learnt from my question to the Policy and Resources Committee at the SDNPA on Thursday last week.

WSCC have allocated £414, 681 to the District Council towards the Covid Outbreak Management Fund. This money is from Government issued payments to upper tier Authorities and together with a sum of £146,955 paid directly to District or Borough Councils gives a total Budget of £561,636. The purpose of this funding is to support 'test,trace and contain' activities, and support for local economies and public health. Any funding not used by end of March 2022 will be returned. And finally,I'm both pleased and sorry to learn of the £90 million fine which has been handed to Southern Water for discharge breeches Pleased that they have been penalised and severely reprimanded, but sorry that this hefty fine, as I'm sure it will,have a major impact on their budget to improve their services elsewhere in the District, so the "mini filtration plant" which has become such a regular feature beside the East Dean Pond and in Charlton may become the 'norm' in future years. Please stay aware and be safe!.
